This agreement is entered into by and between Le Pooch Chateau LLC, and the pet owner(s) _____ and the pet(s) (name) _____.

I (owner) represent that I am the legal owner of the above-named pet(s). Owner understands and agrees the Owner is solely responsible for any harm while Owner's pet(s) is/are attending our Doggie Daycare.

Photo and Video Release: We love to post pictures and videos on Facebook, our website, and/or in any newspaper ads or Instagram. Owner agrees to allow Le Pooch Chateau, in any form, for us at any time, in any media, marketing, advertising, trade or promotional materials without compensation, and Owner releases to Le Pooch Chateau all rights that Owner may possess or claim to such image, likeness, recording, etc.

Pet's Health: Owner understands and agrees that Owner's pet(s) are healthy while attending Le Pooch Chateau and have current vaccination for Rabies, Distemper, and Bordetella (Kennel Cough). Owner is not enrolling any pet(s) that has any condition that could jeopardize the health of other pets or people and has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner's dog is vaccinated for Bordetella (Kennel Cough) there is still a chance that the Owner's dog can contract Kennel Cough. Our Doggie Daycare is limited to small play groups as another precaution to maintain a safe environment as well. Owner agrees that Owner will not hold Le Pooch Chateau responsible if Owner's dog(s) contracts Kennel Cough or other dog-dog transmitted ailments.

Flea and Tick Free: All pets must be flea/tick free. Flea and tick prevention of some sort is highly recommended for your pet(s) to attend Doggie Daycare at Le Pooch Chateau or for overnight boarding.

Group Play: All dogs must have a "trial" stay, free of charge, for us to assess if said pet is able to attend Doggie Daycare. No dog may be admitted to group play who shows any signs of aggression. Any dog demonstrating signs of aggression or behavior deemed unacceptable by Le Pooch Chateau staff may be prohibited from participating in our daycare program or boarding.

Release of Liability: Owner understands and agrees that during normal pet play, Owner's pet(s) may sustain injuries. Le Pooch Chateau caretaker staff monitors pet play to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Our play groups are kept small to maintain the safest environment possible. Owner further understands and agrees that neither daycare/boarding nor any of its employees, staff, or volunteers will be held liable for any kind of illness, injury, or escape of Owner's pet(s) provided that reasonable care and precautions are always followed. Owner hereby releases Le Pooch Chateau staff or volunteers of any liability of any kind whatsoever arising from or as a result of Owner's pet(s) attending Le Pooch Chateau Daycare.

Closing Time: Owner agrees that if Owner's pet(s) is not picked up by specified closing time, then Owner authorizes overnight boarding appropriate for pet(s) and agrees to pay Le Pooch Chateau applicable overnight boarding charges, plus any charge for required food. **Closing times for daycare are as follows: Monday-Friday 7:30 PM; Weekends 7:00 PM; Holidays 6:00 PM**

Right of Refusal: Le Pooch Chateau reserves the right to refuse admittance to any pet(s) or dismiss any pet(s) not meeting or maintaining the health, temperament, or any other daycare/boarding standards. The determination shall be made at the sole discretion of Le Pooch Chateau.

Owner further understands and expressly agrees that each and all provisions and policies in this Agreement shall be in force and effect and shall apply to each and every occasion on which the Owner's pet(s) attend Doggie Daycare. This Agreement shall remain in force and effect between the parties until and unless otherwise cancelled or superseded by something in writing signed by the parties. Owner hereby certifies that Owner has read and understands this Agreement and Release of Liability and the regulations set forth above. By signing this Agreement, Owner agrees to be bound by its terms and conditions.
